In the event that Speedway Redi Mix, Inc employs counsel to collect sums owed by the customer or to enforce any of the terms and conditions of this agreement the customer shall pay Speedway Redi Mix, Inc reasonable attorney's fees and other costs and expenses.

3. Waiver of Jury Trial:

Customer waives all rights to a jury trial on issues in any action or proceeding relating to this agreement, any indebtedness arising hereunder on the transactions contemplated herein and agrees that no attempt shall be made to consolidate, by counterclaim or otherwise, any such action or proceeding with any other action or proceeding in which there is a trial by jury or in which a jury trial cannot be or has not been waived.
